GENERAL RULES

I, the undersigned, declare to accept the clauses and conditions governing participation in the POLLINO DANZA FESTIVAL, as follows:

Art. 1

The Pollino Danza Festival takes place in Episcopia (PZ), Basilicata, at P.zza Arcieri from July 19 to July 30, 2024.

Art.2: Costs

- Registration Fee: €80.00 (except for those purchasing the Open Card)
- Open Day: €120.00
- Single Lesson: €50.00
- Competition Registration Fee: €100.00
- Open Card: €600.00 (Includes registration fee, competition registration fee, access to all classes)
- Bed in the Guesthouse: €150.00 (for the entire period; cost remains unchanged regardless of the number of overnight stays; *limited spots; hurry for reservations)
- Dining Hall (lunch and dinner from July 20 to July 28): €250.00
- Daily Meal: €30.00Single Meal: €20.00

Art. 4: Cancellation

No refunds are provided in case of non-participation, incomplete attendance, or early departure from the stage.

Art.5: Responsibility

Participants take part in the event at their own direct responsibility. The organization is exempt from any civil or criminal liability for any damages to persons or property that may occur during dance practice at the event venues. In the case of participation by a minor, the legal guardian declares to release the organization from any responsibility and obligation to supervise minors.

Article 5.1

With explicit exclusion of the applicability of Articles 1783 and following of the Civil Code, the organizer is not responsible for the loss, theft, or damage to the personal belongings of the participant within the hosting facility.

Art. 6: Declaration of Good Health Certificate

The participant in the stage must possess a medical certificate attesting to their fitness for physical activity and must have presented it to the organization at the time of registration. The participant waives the right to seek compensation from the organization for any accidents that may occur during lessons for reasons not attributable to the organization itself.
